- BRACKETS:** 4 man brackets (paired as close to weight as possible)  
3 man round robins wherever needed.

Late registrations: \$15.00 per wrestler. Entries will be accepted at the door or by telephone.
- AWARDS:** EVERYONE MEDALS. Large 1<sup>st</sup> place medals for 3<sup>rd</sup> through 8<sup>th</sup> grades.
- SCORING:** Three one minute periods Pre K through 4th grades. All periods begin in neutral position. No scoring Pre-K though 2<sup>nd</sup> grade. 5<sup>th</sup> through 8<sup>th</sup> graders: Three 90 second periods wrestlers choice of positions in second and third periods. All Huskerland rules apply.
